Off the court our financials are as strong as they have ever been, and the Committee will be looking at ways to invest in the development of our club in the coming months.

We have also been working on establishing a 'Club base' and will shortly unveil part of the club's history with the erection of an honour board, the club perpetual awards as well as signage on the courts at the Greenvale Recreation Centre. This will ensure the club always has the 'home base' and that we remember our proud history over time...

## Treasurer's Report for the Period 1 July 2018 to 30 June 2019

As at 30 June 2019, the club's bank balance was \$54,038 (2017/18: \$35,250), and the club's Term Deposit was \$20,000 (\$2017/18: \$20,000), giving a combined cash balance of \$74,038, an increase of \$18,788 as at the same time last year.

The main highlights in the club's finances for the 2018/19 financial year included:

- Total income for 2018/19 decreased by \$8,598 to \$62,337 (2017/18: \$70,935);
- Total expenditure for 2018/19 decreased by \$16,787 to \$43,549 (2017/18: \$60,336).

The reasons for the major changes in the income and expenses for the 2018/19 year includes:

#### Income:

- Total player registration income increased by \$9,237 during the year (2018/19: \$59,260, 2017/18: \$50,023). This was predominantly due to an increase in the number of teams / players compared with 2018 and increase in fees to offset the limited fundraising activities planned for the year.
- Fundraising and Sponsorship income represented the largest decline in income by \$17,247 (2018/19: \$2,780, 2017/18: \$20,046)
   This was planned by the Committee to reduce the cost imposed on members from fundraising activities (i.e. no chocolate drive) and limit our key sponsorships to new Team Gold members. Specifically, the major changes included:
  - This year there was no Chocolate Drive which resulted in a reduction in income of \$12,267 and reduction in expenses of \$7,920.
  - o Other sponsorship and fundraising activities generated income of \$2,780.

Thank you to The Pizza & Grill Co and Oporto who continued as our main sponsors during the year and our Team Gold Sponsors.

#### Expenses:

- Court hire for training at Greenvale Recreation Centre remains our largest expense in total at \$25,201 (2017/18: \$20,903), This increased primarily due to an increase in the number of teams and increase in the hourly rate for the hire of Greenvale Rec Centre.
- The fees paid to the Broadmeadows Basketball Association for registering our teams was \$12,720 (2017/18: \$11,640).
- Two areas of increase in expense during the year were:
  - Purchase of new equipment for Coaches and Teams during the year which cost \$3,012 and the purchase of Team Gold / Clash Tops which was funded through Team Gold sponsorships; and
  - Purchase of a new Honour Board which cost \$1,303.
- The two major reasons for the decline in expenses from 2017/18 was due to the timing of the presentation day falling into the 2019/20 year. This cost \$10,106 in 2017/18; and a reduction of \$8,428 in the purchase of GV tops, socks and merchandise in 2018/19 to \$918 (2017/18: \$9,448).

# Registrars Report – AGM August 2019

## Girls:

We currently have 18 girls' teams registered for the winter season which is a record number, a great sign for girls' basketball. We have no teams ageing out next season and expect them all to continue on, with potential new teams from any U8 girls moving up.

At the onset of this season we were able to mix some of our teams up to hopefully obtain better working groups, however, this wasn't skills based.

## **Junior Boys:**

We have 17 Junior boys' teams.

Four of these will advance up in October to U14.

There is no news to report other than multiple requests for skilled coaches or assistance with coaching from current coaches. Many of our coaches have been throw into the position with little or no training, and are feeling the pressure of having to learn skills that they have previously had no experience with.

We would like to ask the club to make this a priority for all coaches across the board.

# Senior Boys:

The senior boys' teams have continued to increase this year by 3 taking them to a total of 21 teams.

Consisting of 7 x U14's, 8 x U16's and 6 xU19's Teams, with only 1 team ageing out this season and looking to increase to 25 teams for the next season.

We also continue to have a number of boys on our waiting list, but find it difficult to place the kids with no experience.

The registrar team have discussed the hope that one day the club will be in a position to run training clinics for kids on our waitlist to help raise the level of skill for new players wanting to start at the club, thus making it easier and more likely that we will be able to place them, particularly at the senior end.

All in the all, the registrar team is working effectively together and trying to bring a more uniform approach to practise an communications across the club.
